Sir,

I am directed to say that the State Government has been paying additional honorarium to the Anganwadi Workers/ Anganwadi Helpers in addition to the normal honorarium as being paid by the Govt. of India and State Government as well.

For some time past it has been under active consideration of the State Government to enhance the rate of additional honorarium to the Anganwadi Workers/ Anganwadi Helpers.

Now, in continuation of this Department's earlier Order No. 3217-SW dated.08.06.2017, I am directed by the order of the Governor to say that the Governor has been pleased to enhance the additional honorarium of the Anganwadi Workers and the Anganwadi Helpers of both Government run ICDS Projects and NGO run ICDS Projects @ **Rs.1000/- p.m w.e.f 01.10.2018.**

The total amount of additional honorarium of both Anganwadi Workers and the Anganwadi Helpers comes to **Rs.2850/- p.m w.e.f 01.10.2018.**




With reference to Memo Nos.4537-SW/P/3SF-14/12 (pt.I) dated 23.08.2018 and 5867-SW/P/3SF-14/12 (pt.I) dated 01.11.2018 of this Department read with Letter No. 11-36/2016-CD dated 20.09.2018 of the Ministry of Women and Child development, Government of India, it is clarified that increase of Rs.1,500/- per month as honorarium to Anganwadi Workers (AWW) by Government of India includes State Share of Rs.600/- to be borne exclusively by the State Government from its own budgetary resources. Similarly, an increase of Rs.750/- per month as honorarium to Anganwadi Helpers (AWH) by Government of India includes State Share of Rs.300/- per month to be borne exclusively by the State Government from its own budgetary resources.

In other words, increase of honorarium by the Government of India from its own resources stands at Rs.900/- per month for Anganwadi Workers and Rs.450/- per month for Anganwadi Helpers and increase of honorarium (including additional honorarium) by the State Government from its own resources for both Anganwadi Workers and Anganwadi Helpers stands at Rs.1,000/- per month as notified earlier by the State Government.

Therefore, the enhancement of Honorarium of AWW stands at Rs.1,900/- (of which Rs.900/- is borne by the Government of India and Rs.1,000/- is borne by the State Government), whereas the enhancement of the honorarium for the AWH stands at Rs.1,450/- (of which Rs.450/- is borne by the Government of India and Rs.1,000/- is borne by the State Government).

Thus, the total emoluments payable to Anganwadi Workers and Anganwadi Helpers are Rs.6,750/- and Rs.4,800/- per month respectively.

Sir,

I am directed to say that the State Government has been paying additional honorarium to the Anganwadi Workers and Anganwadi Helpers borne on its own budget, over and above the honorarium as being paid on a 60:40 cost sharing basis between Govt. of India and State Govt.

In continuation of this Department's earlier Order No.5867-SW/P/3SF-14/12 (Pt.I) dated.01.11.2018 read with 5994(23)-SW/3SF-14/12 (Pt.I) dated 05.11.2018, I am directed by the order of the Governor to say that the Governor has been pleased to enhance the additional honorarium, being paid exclusively from the State's own budget, of the Anganwadi Workers (AWW) and the Anganwadi Helpers (AWH) of both Government run ICDS Projects and NGO run ICDS Projects @ Rs.500/- p.m w.e.f 01.02.2019.

The total amount of additional honorarium payable to each Anganwadi Worker (AWW) and each Anganwadi Helper (AWH) therefore comes to Rs.2750/- (Rs.2250+Rs.500) p.m and Rs.3050/- (Rs.2550+Rs.500/-) p.m respectively w.e.f 01.02.2019.



Sir,

I am directed to say that the State Government has been paying additional honorarium to the voluntary workers under ICDS Scheme i.e. to the Anganwadi Workers and Anganwadi Helpers, entirely from State Budget, in addition to the honorarium paid by the Government of India as well as State Government in the 60:40 cost sharing ratio.

In continuation to this Department's earlier Order No. 972-SW/P/3SF-14/12(Pt. I), dated 15/02/2019, I am directed by the order of the Governor to say that the Governor has been pleased to enhance the additional honorarium @ Rs. 1000/- (Rupees one thousand only) per month w.e.f. 01.12.2020, for each and every Anganwadi Worker and Anganwadi Helper under both Government run ICDS Projects and NGO run ICDS Projects of West Bengal, to be paid exclusively from the State's own budget.

The total amount of additional honorarium payable to each Anganwadi Worker (AWW) and each Anganwadi Helper (AWH) therefore, comes to Rs. 3750/- (Rs. 2750 + Rs. 1000) per month and Rs. 4050/- (Rs. 3050 + Rs. 1000) per month respectively w.e.f. 01.12.2020.
