Subject: Grievance regarding Honorarium, pension and related matters - regarding.


Sir/Madam,

Respected Mam,

On behalf of our organization, with due respect and humble submission, we beg to state your kind attention to an issue affecting the incumbent AWH of our region whose promotion have been affected with the release of new government notification of 11.12.2023, the recent government notification, with academic qualification requirement up to the Higher Secondary level for the promotion to worker post has been depriving many AWH. Specially in Darjeeling and Kalimpong the Promotion AWH has not been taking place since 2012 whereas in other districts of our state the promotion for AWH to AWW has been initiated almost for three times. Therefore the AWH of Darjeeling and Kalimpong have been relieved from their promotional opportunity since 2012.

Now the new government notification set the academic criteria of Higher Secondary pass for the AWW which is depriving many AWH from their promotion to AWW who have been serving since 17 to 18 years.

The dedicated service sundered by these helpers in the ICDS project for several years deserves recognition and a fair chance for career progression.
